20200206/2 To receive comments and concerns from members of the public

Residents in Wheat Close came to discuss their concerns about the parking in Wheat Close. Neighbourhood coach advised residents that they could be evicted if they continue to park on the grass. The Neighbourhood coach also advised residents not to attend the Parish Council meeting and not to raise the parking issues with the Parish Council. The council were shocked to hear that residents were told not come to the council meeting and that any member of the parish has the right to attend a council meeting and express any concerns they have. Clerk will contact Bromford regarding this matter. The Car park where the garages were is not available as full of cars from residents in The Leasows. JB advised that Rhodri Grey is coming to look at the option of tarmacing the grass also said that although the tree officer has said the tree is healthy could it be possibly be reduced and make the crown smaller. The Parish Council has also asked if they could look at the lighting by the garages and a suggestion of reinforced grass (i.e. using plastic or concrete with grass) for the verges. A member of the parish emailed re grit and empty grit bins. SW will talk to Paul Teague and JB to Rhodri Grey about the grit bins and checking their levels.
