Member of the public informed the PC that the road name sign for Wheatclose has fallen off its metal supports. JB offered to inform Rhodri Grey about this when he speaks to him next. The large horse chestnut tree in the close is causing concern due to overhanging branches and some delivery vehicles are refusing to access the close due to this. JB offered to bring this up again with the tree officer again as their previous inspection resulted in no action deemed necessary.
